In re Holocaust Victim Assets Litigation
Case No. CV96-4849

Certified Denial

to Claimant Fred Jack Abraham

Claimed Account Owner: Julius Abraham¹

Claim Number: 217610/RT

This Certified Denial is to the claim of Fred Jack Abraham (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s father, Julius Abraham (Abrahams) (the “Claimed Account Owner”).

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that Julius Abraham, who was Jewish, resided in Jesberg and Niederurff, Germany. The Claimant further stated that his father may also have spent some time in Fulda, Kassel and Frankfurt am Main, Germany.

The CRT’s Investigation

The CRT matched the name of Julius Abraham (Abrahams) to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

¹ The Claimant should note that this determination relates only to the Claim Number and Claimed Account Owner stated above, and that the CRT is aware that the Claimant may have submitted other claims.

The CRT's Analysis

Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Julius Abraham (Germany)

Account Identification Number: 1000023

Specifically, the Claimant stated that his father, Julius Abraham, resided in Jesberg and Niederurff and also may have spent some time in Fulda, Kassel and Frankfurt am Main. In contrast, the records show that the account owner resided in a different city, which is over 350 kilometers from Jesberg and Niederurff; over 300 kilometers from Kassel and over 400 kilometers from Fulda and Frankfurt am Main. The CRT notes that the account owner's city of residence is a major urban center. The CRT further notes that Jesberg is a minor town; that Niederurff is a village; that Fulda is a major city and that Kassel and Frankfurt am Main are major urban centers and that Jesberg, Niederurff and Fulda are significantly closer to the major urban centers Kassel and Frankfurt am Main than to the account owner's city of residence, thus rendering it unlikely that a resident of Jesberg, Niederurff, Fulda, Kassel or Frankfurt am Main would indicate the account owner's distant city of residence as his/her place of residence, even for the purpose of maintaining of a Swiss bank account.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Julius Abraham closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
