In re Holocaust Victim Assets Litigation
Case No. CV96-4849

Certified Denial

to Claimant Michel Bodkier

Claimed Account Owners: Fanny Auerbach and Mordechai Auerbach¹

Claim Number: 210647/RT

This determination is based on the claim of Michel Bodkier (the “Claimant”) to Swiss bank accounts potentially owned by Fanny Auerbach and Mordechai Auerbach. The CRT did not locate an account belonging to Mordechai (Moshe, Moise) Auerbach (Awerbuch, Awerbach) in the Account History Database prepared pursuant to the investigation of the Independent Committee of Eminent Persons (“ICEP” or “ICEP Investigation”), which identified accounts probably or possibly belonging to Victims of Nazi Persecution, as defined in the Rules Governing the Claims Resolution Process, as amended (the “Rules”).

This Certified Denial is to a Swiss bank account potentially owned by the Claimant’s relative, Fanny (Feichele) Auerbach (Awerbuch, Awerbach) (the “Claimed Account Owner”).

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that Fanny Auerbach, who was Jewish, held a Swiss bank account. The Claimant did not provide any further information about Fanny Auerbach.

The CRT’s Investigation

The CRT matched the name of Fanny (Feichele) Auerbach (Awerbuch, Awerbach) to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records

indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

The CRT's Analysis

Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Fanny Auerbach (Lwow, Poland, power of attorney holder)²

Account Identification Number: 1014651

Specifically, the Claimant stated that his relative, Fanny Auerbach, owned a Swiss bank account. The CRT notes that the Claimant did not identify the account owner, who is indicated to be closely related to the power of attorney holder. The CRT further notes that the account has been awarded to different claimants who identified the account owner and the power of attorney holder and who identified further unpublished information about the account owner including his relation to the power of attorney holder, his occupation and the year he died.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

² The CRT notes that on the 2001 list of account owners the account was published as belonging to Fanny Auerbach. Upon careful review of the records the CRT determined that Fanny Auerbach only was the power of attorney holder and that the account belonged to a different person.

Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Fanny Auerbach and Mordechai Awerbuch closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

Certification of the Denial
