## **Certified Denial**

to Claimant [REDACTED 1]  
also representing [REDACTED 2]

**Claimed Account Owner: Hans Lederer<sup>1</sup>**

Claim Number: 202735/RT

This Certified Denial is to the claim of [REDACTED 1] (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s relative, Hans Lederer (the “Claimed Account Owner”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

### **Information Provided by the Claimant**

The Claimant submitted a claim stating that Hans Lederer, who was Jewish, was an owner of an international booking agency called *Hans Lederer*. The Claimant further stated that Hans Lederer was married to [REDACTED].

### **The CRT’s Investigation**

The CRT matched the name of Hans Lederer to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

## The CRT's Analysis

### Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

*Name: Hans Lederer (Vienna, Austria)*

*Account Identification Number: 4021703*

*Specifically, records from the Austrian State Archive (Archive of the Republic, Finance) regarding the assets of Hans Lederer indicate Hans Lederer's date of birth, the name of his spouse, and his occupation.<sup>2</sup> A comparison of this information to the information in the bank's records indicates that the Hans Lederer named in the archival records is the account owner. The Claimant stated that his relative, Hans Lederer, was married to [REDACTED] and was an owner of an international booking agency called "Hans Lederer." In contrast, the information in the bank's records and the archival records indicate that the account owner was married to a different person and had a different profession.*

### Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

<sup>2</sup> By decree on 26 April 1938, the Nazi Regime required all Jews who resided within the Reich, or who were nationals of the Reich, including Austria, and who held assets above a specified level to register all their assets as of 27 April 1938 (the "1938 Census"). These asset declarations and accompanying documents are located in the Austrian State Archive (Archive of the Republic, Finance).

Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

**Scope of the Denial**

The CRT now considers the Claimant's claim to the accounts of Hans Lederer closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
