In re Holocaust Victim Assets Litigation
Case No. CV96-4849

Certified Denial

to Claimant [REDACTED]

Claimed Account Owners: Jules Levy and Elise Levy¹

Claim Number: 707968/RT

This determination is based on the claim of [REDACTED] (the “Claimant”) to Swiss bank account potentially owned by Jules Levy and Elise Levy. The CRT did not locate an account belonging to Elise Levy in the Account History Database prepared pursuant to the investigation of the Independent Committee of Eminent Persons (“ICEP” or “ICEP Investigation”), which identified accounts probably or possibly belonging to Victims of Nazi Persecution, as defined in the Rules Governing the Claims Resolution Process, as amended (the “Rules”).

This Certified Denial is to a Swiss bank account potentially owned by the Claimant’s relative, Jules Levy (the “Claimed Account Owner”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that her father, Jules Levy, who was Jewish, was a cattle dealer who resided in Forbach, Charmes, Lyon, and Bretagne, France, and in Switzerland before and during the Second World War. In a telephone conversation with the CRT, the Claimant stated that after the Second World War, her family resided in Strasbourg and Colmar, France. The Claimant did not indicate any academic or professional titles held by her father.

The CRT’s Investigation

The CRT matched the name of Jules Levy to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names,

including name variations provided by Yad Vashem, The Holocaust Martyrs' and Heroes' Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

The CRT's Analysis

Identification of the Account Owner

The list below contains names of account owners that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Jules Levy (Strasbourg, France)

Account Identification Numbers: 5032092; 5032093; 5032094; 5032560

Specifically, the Claimant stated that her father, Jules Levy, was a cattle dealer who resided in Forbach, Charmes, Bretagne and Lyon, France, and in Switzerland before and during the Second World War and only moved to Strasbourg after the Second World War. The Claimant did not indicate any academic or professional titles held by her father. In contrast, the records show that the account owner held such a title, which is inconsistent with the Claimant's father's profession as a cattle dealer. The records further show that the account owner resided in Strasbourg decades before the Claimant's family moved to Strasbourg.

Name: Jules Lévy (Colmar, France)

Account Identification Numbers: 5032383

Specifically, the Claimant stated that her father, Jules Levy, resided in Forbach, Charmes, Bretagne and Lyon, France, and in Switzerland before and during the Second World War and only moved to Colmar after the Second World War. In contrast, the records show that the account owner resided in Colmar over a decade before the Claimant's family moved to Colmar. The CRT further notes that the Claimant did not identify the joint account owner, who was closely related to the account owner.

Name: Jules Lévy (Strasbourg, France)

Account Identification Number: 5032559

Specifically, the Claimant stated that her father, Jules Levy, resided in Forbach, Charmes, Bretagne and Lyon, France, and in Switzerland before and during the Second World War and only moved to Strasbourg after the Second World War. In contrast, the records show that the account owner resided in Strasbourg decades before the Claimant's family moved to Strasbourg.

Name: Julien Lévy (Paris, France)

Account Identification Number: 5034587

Specifically, the Claimant stated that her father, Jules Levy, resided in Forbach, Charmes, Bretagne and Lyon, France, and in Switzerland before and during the Second World War. In contrast, the records show that the account owner resided in Paris, France, which is over 350

kilometers from Forbach and Charmes and over 400 kilometers from Bretagne and Lyon. The CRT further notes that Paris is a major urban center whereas Forbach and Charmes are smaller cities and that there are several major cities significantly closer to Forbach and Charmes than Paris, thus rendering it unlikely that a resident of Forbach or Charmes would indicate Paris as his/her place of residence, even for the purposes of maintaining a Swiss bank account.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules, the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Jules Levy and Elise Levy closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

Certification of the Denial

The CRT certifies this Denial for approval by the Court.
