In re Holocaust Victim Assets Litigation
Case No. CV96-4849

Certified Denial

to the Estate of Joseph Regensburger

Claimed Account Owners: Jacob Regensburger and Amalie Regensburger¹

Claim Number: 203158/HU

This Certified Denial is to the claim of Joseph Regensburger (the “Claimant”) to a Swiss bank account potentially owned by the Claimant’s relatives, Jacob (Jakob) Regensburger and Amalie (Amalia) Regensburger (the “Claimed Account Owners”).

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that Jacob Regensburger, who was Jewish, was a horse breeder and butcher who resided in Sulzburg and Hemau in Germany until 1928, when he moved to France. The Claimant provided the death certificate of Jacob Regensburger, which indicates that Amalie Regensburger, who was also Jewish, had the maiden name of Sondheim.

The CRT’s Investigation

The CRT matched the names of Jacob (Jakob) Regensburger and Amalie (Amalia) Regensburger to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owners. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owners. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owners.

¹ The Claimant should note that this determination relates only to the Claim Number and Claimed Account Owner stated above, and that the CRT is aware that the Claimant may have submitted other claims.

The CRT's Analysis

Identification of the Account Owners

The list below contains names of account owners that match the names of the Claimed Account Owners and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Jacob Regensburger (Germany)

Account Identification Numbers: 1010852, 1010853 and 1010854

Specifically, the Claimant stated that his relative, Jacob Regensburger, resided in Germany until 1928, when he moved to France. In contrast, the records show that the account owner resided in Germany several years after 1928.

Name: Amalie Regensburger (AKA Bauer, Frl. Amalie) (Yokohama, Japan)

Account Identification Numbers: 5034388 and 5034389

Specifically, the Claimant provided the death certificate of Jacob Regensburger, which indicates that Amalie Regensburger's maiden name was Sondheim. In contrast, the records show that the account owner had a different maiden name.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Jacob Regensburger and Amalie Regensburger closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

Certification of the Denial
