In re Holocaust Victim Assets Litigation  
Case No. CV96-4849

## **Certified Denial**

to Claimant Jacqueline Reisner

**Claimed Account Owner: Johanna Reisner<sup>1</sup>**

Claim Number: 401750/SB

This Certified Denial is to the claim of Jacqueline Reisner (the “Claimant”) to a Swiss bank account published on the list of account owners in 2005 and potentially owned by her relative Johanna Reisner (the “Claimed Account Owner”).

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

### **Information Provided by the Claimant**

The Claimant submitted a claim stating that Johanna Reisner, who was Jewish, resided in Wiesbaden, Germany starting in 1919. The CRT also notes that the Claimant provided a detailed family tree charting seven generations, with over sixty family members.

### **The CRT’s Investigation**

The CRT matched the name of Johanna Reisner to the names of all account owners, and power of attorney holders, in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owner. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owner. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owner.

## **The CRT's Analysis**

### Identification of the Account Owner

The list below contains names of account owners, and power of attorney holders, that match the name of the Claimed Account Owner and the reasons why the CRT has concluded that the Claimed Account Owner and the account owner, or power of attorney holder, are not the same person. If the account owner's place of residence was published, that place of residence is also listed.

*Name: Johanna Reisner*

*Account Identification Numbers: 1010876 and 1010877*

*Specifically, the Claimant stated that her relative, Johanna Reisner, resided in Wiesbaden. In contrast, the records show that the account owner resided in a different city which is over 150 kilometers from Wiesbaden. The CRT notes that Wiesbaden is a major urban center, whereas the account owner's place of residence is a small town, rendering it unlikely that a resident of Wiesbaden would indicate this distant small town as their place of residence, even for the purposes of maintaining a Swiss bank account. The CRT further notes that the Claimant did not identify the joint account owner, even though this person appears to be very closely related to the account owner.*

### Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

**Scope of the Denial**

The CRT now considers the Claimant's claim to the accounts of Johanna Reisner closed. Please note that this decision applies only to the Claim Number and Claimed Account Owner identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
