**Claimed Account Owners: Julius Rosenthal, Hermann Rosenthal, Ludwig Rosenthal
and Charlie Stuart¹**

Claim Number: 773354/SB

This determination is based on the claim of [REDACTED] (the “Claimant”) to a Swiss bank account potentially owned by Julius Rosenthal, Hermann Rosenthal, Ludwig Rosenthal and Charlie Stuart. The CRT did not locate an account belonging to Charlie Stuart in the Account History Database prepared pursuant to the investigation of the Independent Committee of Eminent Persons (“ICEP” or “ICEP Investigation”), which identified accounts probably or possibly belonging to Victims of Nazi Persecution, as defined in the Rules Governing the Claims Resolution Process, as amended (the “Rules”).

This Certified Denial is to the Swiss bank accounts published on the list of account owners in 2005 and potentially owned by the Claimant’s relatives, Julius Rosenthal, Hermann Rosenthal and Ludwig Rosenthal (the “Claimed Account Owners”).

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

Information Provided by the Claimant

The Claimant did not provide any information in her claim regarding Julius Rosenthal, Hermann Rosenthal, Ludwig Rosenthal, other than to state that her family was Jewish. In a telephone conversation on 17 January 2006, the Claimant stated that she was not able to provide any detailed information regarding her relatives, but did state that the Rosenthal family resided in the Stettin area of Germany (today Szczecin, Poland).

¹ The Claimant should note that this determination relates only to the Claim Number and Claimed Account Owners stated above, and that the CRT is aware that the Claimant may have submitted other claims.

The CRT's Investigation

The CRT matched the names of Julius Rosenthal, Hermann Rosenthal, Ludwig Rosenthal to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owners. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs' and Heroes' Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owners. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owners.

The CRT's Analysis

Identification of the Account Owners

The list below contains names of account owners that match the names of the Claimed Account Owners and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Julius Rosenthal

Account Identification Number: 5033054

Specifically, the Claimant stated that her relative, Julius Rosenthal, resided in Germany. In contrast, the records show that the account owner resided in a different country.

Name: Hermann Rosenthal

Account Identification Number: 1010943

Specifically, the Claimant stated that her relative, Hermann Rosenthal, resided in Germany. In contrast, the records show that the account owner resided in a different country.

Name: Ludwig Rosenthal

Account Identification Numbers: 1012248 and 1012249

Specifically, the Claimant stated that her relative, Ludwig Rosenthal, resided in Germany. In contrast, the records show that the account owner resided in a different country.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules, the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Julius Rosenthal, Hermann Rosenthal, Ludwig Rosenthal and Charlie Stuart closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

Certification of the Denial

The CRT certifies this Denial for approval by the Court.
