Certified Denial

to Claimant [REDACTED]

Claimed Account Owners: Fritz Taussig, Ana Taussig, Rene Taussig and Curt Bloch¹

Claim Number: 221947/RT

This determination is based on the claim of [REDACTED] (the Claimant) to Swiss bank accounts potentially owned by Fritz Taussig, Ana Taussig, Rene Taussig and Curt Bloch. The CRT did not locate an account belonging to Rene (Ruth, Pussy) Taussig (Bloch) and Curt Bloch in the Account History Database prepared pursuant to the investigation of the Independent Committee of Eminent Persons (ICEP or ICEP Investigation), which identified accounts probably or possibly belonging to Victims of Nazi Persecution, as defined in the Rules Governing the Claims Resolution Process, as amended (the Rules).

This Certified Denial is to a Swiss bank account potentially owned by the Claimant's relatives, Fritz Taussig and Ana (Anna) Taussig (Stein) (the "Claimed Account Owners").

All denials are published, but where a claimant has requested confidentiality, as in this case, the names of the claimant, any relatives of the claimant other than the account owner, and the bank have been redacted.

Information Provided by the Claimant

The Claimant submitted a claim stating that Fritz Taussig and Ana Taussig, who were Jewish, were married and resided in Prague, Czechoslovakia (now Czech Republic). The Claimant further stated that Fritz Taussig was her great-uncle. The Claimant did not indicate any academic or professional title held by Fritz Taussig.

The CRT's Investigation

The CRT matched the names of Fritz Taussig and Ana (Anna) Taussig (Stein) to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owners. In doing so, the CRT used advanced name matching systems and computer programs,

and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs' and Heroes' Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified. However, a close review of the relevant bank records indicated that the information contained therein was inconsistent with the information the Claimant provided regarding the Claimed Account Owners. Accordingly, the CRT was unable to conclude that any of these accounts belonged to the Claimed Account Owners.

The CRT's Analysis

Identification of the Account Owners

The list below contains names of account owners that match the names of the Claimed Account Owners and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

Name: Fritz Taussig (Germany)

Account Identification Number: 1013372

Specifically, the Claimant stated that her relative, Fritz Taussig, resided in Czechoslovakia. The Claimant did not indicate any academic or professional title held by her relative. In contrast, the records show that the account owner held such a title and resided in Germany.

Name: Fritz Taussig (Vienna, Austria)

Account Identification Number: 5025688

Specifically, the Claimant stated that her relative, Fritz Taussig, resided in Czechoslovakia. The Claimant did not indicate any academic or professional title held by her relative. In contrast, the records show that the account owner held such a title and resided in Austria.

Name: Fritz Taussig

Account Identification Numbers: 5029763; 5033626

Specifically, the Claimant stated that her relative, Fritz Taussig, resided in Czechoslovakia. The Claimant did not indicate any academic or professional title held by her relative. In contrast, the records show that the account owner held such a title and resided in a different country.

Name: Anna Stein (Austria)

Account Identification Numbers: 1014000; 1014001

Specifically, the Claimant stated that her relative, Ana Taussig, resided in Czechoslovakia. In contrast, the records show that the account owner resided in Austria.

Name: A. Taussig

Account Identification Number: 6002178

Specifically, the Claimant indicated that her relative, Ana Taussig was her great-aunt. In contrast, the records show that the account owner was male.

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at www.crt-ii.org.

Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

Scope of the Denial

The CRT now considers the Claimant's claim to the accounts of Fritz Taussig, Ana Taussig, Rene Taussig and Curt Bloch closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.

Certification of the Denial

The CRT certifies this Denial for approval by the Court.
