## **Certified Denial**

to Claimant Andrew Schuller

**Claimed Account Owners: Gertrude Taussig and Georg Taussig<sup>1</sup>**

Claim Number: 401536/SB

This Certified Denial is to the claim of Andrew Schuller (the “Claimant”) to the Swiss bank account G. Taussig, as published on the list of account owners in 2005, and potentially owned by the Claimant’s relatives, Gertrude Taussig or Georg Taussig (the “Claimed Account Owners”).

All denials are published. Where a claimant has not requested confidentiality, as in this case, only the name of the bank has been redacted.

### **Information Provided by the Claimant**

The Claimant submitted a claim stating that Gertrude Taussig and Georg Taussig, who were Jewish, resided in Austria.

### **The CRT’s Investigation**

The CRT matched the names of Gertrude Taussig and Georg Taussig to the names of all account owners in the Account History Database and identified accounts belonging to individuals whose names match, or are substantially similar to, the name of the Claimed Account Owners. In doing so, the CRT used advanced name matching systems and computer programs, and considered variations of names, including name variations provided by Yad Vashem, The Holocaust Martyrs’ and Heroes’ Remembrance Authority, in Jerusalem, Israel, to ensure that all possible name matches were identified.

## **The CRT's Analysis**

### Identification of the Account Owner

The list below contains names of account owners that match the names of the Claimed Account Owners and the reasons why the CRT has concluded that the Claimed Account Owners and an account owner are not the same person. If an account owner's place of residence was published, that place of residence is also listed.

*Name: G. Taussig*

*Account Identification Number: 6002180*

*Specifically, the Claimant claimed an account belonging to his relatives Gertrude Taussig and Georg Taussig. The Claimant stated that his relatives resided in Austria. The bank records indicate that the account owner was male and resided in a different country.*

The Claimant should note that all accounts awarded by the CRT are published upon release on the CRT's website at [www.crt-ii.org](http://www.crt-ii.org).

### Right of Appeal and Request for Reconsideration

Pursuant to Article 30 of the Rules Governing the Claims Resolution Process, as amended (the "Rules"), the Claimant may appeal this decision or submit a request for reconsideration within ninety (90) days of the date of the letter accompanying this decision.

An appeal must be based upon a plausible suggestion of error regarding the CRT's conclusions set out in this decision. Any appeals which are submitted without a plausible suggestion of error shall be summarily denied. A request for reconsideration must be based on new documentary evidence not previously presented to the CRT that, if considered, would have led to a different outcome of the claim. Claimants should briefly explain the relevance of the newly submitted documents in view of the conclusions stated in the certified decision.

If more than one account has been treated in this decision, the Claimant should identify the account, including, where available, the Account Identification Number, that forms the basis of the appeal and/or request for reconsideration.

### **Scope of the Denial**

The CRT now considers the Claimant's claim to the accounts of Gertrude Taussig and Georg Taussig closed. Please note that this decision applies only to the Claim Number and Claimed Account Owners identified herein, and that the CRT is aware that the Claimant may have claimed accounts held by other persons or entities both in the Claim Number specified above and in other claims submitted to the CRT.
